If you would like your child to stay for a school provided lunch, this will be served during the afternoon session and the cost will be payable directly to Dolce, the catering company.

Alternatively, children staying all day or arriving at midday may bring a nut-free packed lunch.

### **Funded Sessions:**

All children are entitled to 15 hours of funded pre-school sessions from the term after their 3<sup>rd</sup> birthday. These hours can be used between 9.00 am and 3.00 pm only.

Parents/Carers of children who are eligible for 30 funded hours per week can use these hours between 9.00 am and 3.00 pm subject to the correct claiming and validation.

Parents can apply 16 weeks before their child's third birthday.

The validity start date shown on the code issued by HMRC will be the date the code was issued, not the date the child can start accessing the 30 hours free childcare.

Every three months, parents will be asked to reconfirm that they are still eligible.

In order to access the 30 hours childcare, an eligibility code must be issued before the end of the funding period to enable a start in the following funding period. If a code is not issued by HMRC before the deadline, the child will have to wait until the following funding period (term) before they can take up the 30 hour entitlement.

### **Late Collection Charge:**

Please be aware that a late collection charge of £15.00 per child will be applied for every 15 minutes after the end of their booked session. Parents/carers will be asked to sign the late book and given a copy to cross reference with their invoice.

**Hours:** Monkfield Park Care and Learning Centre is open from 8.00 am to 6.00 pm, Monday to Friday, Term time only. It will close in line with Monkfield Park Primary School Inset days,.

**Fees:** Fees are payable monthly by cash, cheque, childcare voucher or tax-free childcare (see [www.gov.uk/tax/free-childcare](http://www.gov.uk/tax/free-childcare) for details) and must be paid by the date shown on the invoice, in order to keep accounts up to date. Fees are reviewed annually and at least one month's notice will be given of any changes.
